General

Kaur Legal respects your personal data and ensures that any personal information provided to the firm or otherwise obtained is treated confidentially.

Personal data includes all information about an individual. Data that indirectly reveals something about someone is also considered personal data. The **General Data Protection Regulation (GDPR)** imposes an obligation on organisations that process personal data: the data subject whose data is being processed must be informed about how and why their personal data is used. With this **Privacy Statement**, Kaur Legal fulfils this obligation to provide information.

Processing and communication

Kaur Legal processes personal data to provide (legal) services, to improve its services and to facilitate communicating with you as a data subject.

Purpose of processing personal data

Kaur Legal only processes the personal data listed below for the purposes specified.

- Providing legal services, including executing agreements and conducting (legal) proceedings;
- Receiving payments and declarations;
- Giving advice, mediation, and referrals;
- Ensuring compliance with the legal and regulatory obligations applicable to Kaur Legal;
- Carrying out marketing and communication activities;
- Possible recruitment and selection (applications).

What personal data is processed?

Kaur Legal processes the categories of personal data listed below.

- (i) Data obtained in the context of the service, including data that you, as a data subject, have provided to Kaur Legal yourself:
 - First and last name, gender, date of birth, place of birth, nationality, address details, social security number, telephone number, e-mail address, payment and billing details;
 - Other personal data that you actively provide, for example by filling in the contact form on the website, during a (telephone) intake or in correspondence;



- (ii) Data collected or generated by the Kaur Legal website:
 - IP address, internet browser and device type;
 - Location data;
 - Data about your activities on the Kaur Legal website;
- (iii) Data obtained from other (public) sources:
 - Data received from a counterparty or other parties involved in the case;
 - Data from the Trade Register of the Chamber of Commerce, the Land Registry or Municipal Registrations.

Basis for processing personal data

Kaur Legal processes the personal data mentioned above solely based on the grounds outlined in Article 6 of the GDPR.

- Performance of a contract: to provide legal services, such as drafting contracts, offering legal advice, or representing clients in court cases;
- Legal obligation: to comply with legal requirements, such as tax legislation, anti-money laundering regulations (AML), or retention obligations for legal documents;
- Explicitly obtained consent from data subject(s): for example, for marketing purposes or sharing data with third parties (e.g., experts or other legal entities);
- Legitimate interest: for example, for administrative purposes, data security, or to protect Kaur Legal's legal interests.

Sharing personal data with third parties

Kaur Legal only shares your personal data with third parties to the extent necessary for providing services and in accordance with the purposes mentioned above. You can think of:

- Observation of the practice by another lawyer;
- Conducting an expert investigation;
- Engaging another third party on behalf of Kaur Legal, such as an IT supplier, or
- Providing your personal data during (legal) proceedings or in correspondence with the other party.
- Providing your personal data to a third party, such as a supervisory authority or a competent (government) agency, when required by law.

A processing agreement is entered into with the third party that processes your personal data on behalf of and for Kaur Legal, ensuring this party is also bound by the GDPR. Third parties engaged by Kaur Legal, such as accountants or civil-law notaries, who provide services as data controllers, remain responsible for GDPR compliance when processing your personal data further.

Security of personal data

Kaur Legal regards the security and safeguarding of your personal data as very important, and therefore takes suitable measures to protect your data. When Kaur Legal utilises the services of third parties, such as an IT provider, Kaur Legal will establish agreements with them regarding the protection of your personal data.



Retention period of personal data

Kaur Legal does not store personal data for longer than legally necessary or beyond the purpose of the data processing mentioned above.

Privacy rights of data subjects

You may submit a request for inspection, correction, restriction, objection, data portability, deletion of your personal data, or withdrawal of your previous consent using the contact details below. You will receive a response from Kaur Legal within four weeks of your request.

Kaur Legal may not be able to fully comply with your request as a data subject. Consider the confidentiality obligations of lawyers and legal retention periods. Kaur Legal will only process requests related to your own personal data.
